5. Registry is directed to summon the records from the Registrar of Copyrights.

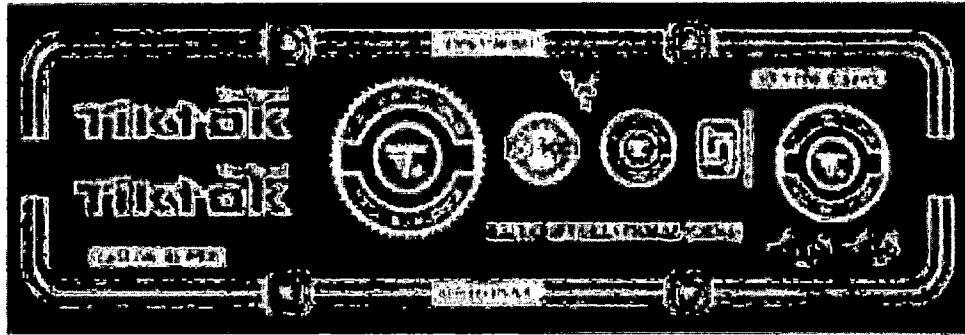
