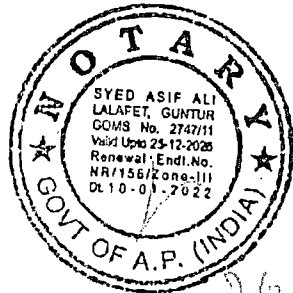

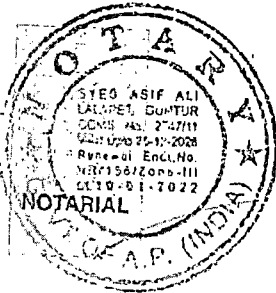

I.A. 2408/2026 (Delay)

1. The application seeking condonation of delay in re-filing is *sans* material particulars. Ordinarily, this Court would have condoned the delay in re-filing, however, the manner in which the petitioner has been pursuing the Registry, and clearing the defects, marked from 04.12.2024 till the petition was finally filed on 27.01.2026, creates a doubt as to the *bona fide* of the petitioner.
2. Ms. Sindoor, leaned counsel appearing for the petitioner seeks and is granted two weeks' time to place on record a detailed affidavit within two weeks giving the complete details from the time the petition was filed on 03.12.2024 till 27.01.2026, highlighting all the milestones of the defects raised and the same having been cured. Advance copy thereof be furnished to the learned counsel for the respondents.
