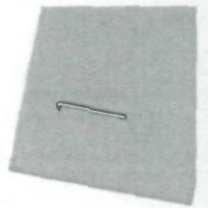

1. The disputes between the parties stand settled, and the infringement suit instituted by the petitioner against the respondent decreed on that basis by the Division Bench of this Court on 12 May 2023 in FAO (Comm) 131/2021.

2. Mr. Anish Chawla, learned Counsel for the respondents submits that, in accordance with the undertaking contained in the joint compromise application filed by the parties before the Division Bench of this Court in FAO (COMM) 131/2021 [*Kunal Chandani & Anr. v. M/s Rajani Products*], he has no objection to a direction being issued to the Registrar of Copyrights to remove, from the register of Copyrights, the Registration No. A-104297 of 2013 granted to his



clients.

3. Accordingly, the Registrar of Copyrights is directed to forthwith cancel the impugned Registration No. A-104297 of 2013 and remove it from the Register of Copyrights.
4. Let this be done within a period of one week from today.
5. The petition stands allowed in the aforesaid terms.
