Mr. Saikrishna, Advocate and Mr. Amit Dutta appearing on behalf of IPRS while arguing the application of intervention has suggested that royalty in the underlying works (lyrics and musical composition) of sound recording with respect to FM Radio Stations which are the subject matter of the cases should also be fixed independently at the time of fixing the royalties of sound recording. It is stated by them that actually the applicants ought to have sought this direction through a separate prayer, but for reasons known to them, no specific relief thereof is sought.

IPRS Counsels referred large number of documents and decisions in this regard. It is also stated by them that under Rule 31 of Copyrights Rules, 2013, the IPAB has suomoto power to fix the royalties. In the intervention application IPRS has raised all the relevant pleas and also the suggestions. We have also heard the authors and experts in this regard who have filed suggestions. The liberty for filing a fresh application to IPRS is already granted.

Prima facie we are of the view that IPRS is an interested party as given in Rule 31 of Copyright Rules 2013 and therefore, necessary party to be heard. Subject to hearing of all the parties, final orders will be passed, and prayer for fixing royalties will be considered after hearing the case on merit. The application of the IPRS is decided accordingly.
